**Terms & Conditions in regard to supply of "KOTA STONE" :**

1. Tenderer/Quotationer should quote the rate per Sq. Ft. of 'Kota Stone' ex Jhalawar, Rajasthan. The rate may also be quoted per Sq. Ft. inclusive of cost of special polishing (pre-mirror polish in furnished stage) inclusive cost of packaging especially in separate packets @ 02 (two) slab each with special packing materials for protection of the polished Kota Stone in long transit during loading, brushing, stacking and to protect any damage to the stone in long transit from Rajasthan (original source) to Agartala, Tripura. Care should also be taken to supply the Kota Stone after careful sorting and keeping the uniformity of specification, grains, colour and shades up to the great extent. Rates may be quoted ex Jhalawar, Kota Rajasthan.

**Particulars – size /measurement of Kota Stone Tiles :**


i) 5' X 2' High Polish	- 145 Pcs	= 1,450 Sq. Ft.
ii) 3'.5" X 2' High Polish	- 145 Pcs.	= 1,015 Sq. Ft.
iii) 7'.5" X 2' High Polish	- 10 pcs.	= 150 Sq. Ft.
iv) 22" X 22" Mirror Polish Box packing Kota Stone Tiles.	= 5,025 Pcs.	

**Total = 20,100 Sq. Ft.approx..**

The school authority /Tender Inviting Authority shall bear the transportation cost from Kota, Rajasthan to Agartala, Tripura and other charges etc separately item-wise.

2. Supplier or Manufacturer or Mines Owner or Authorized Dealer must submit his source of original procurement of 'Kota Stone';
3. Photocopy of the original Mines Owner Certificate from the Department of Mines & Geology, Rajasthan, Govt. of Rajasthan and in case of Dealer, authorized Dealership Certificate will have to be produced/submitted along with the Tender;
4. Supplier or Manufacturer or Mines Owner or Authorized Dealer must submit their I.T. PAN Card (photocopy).
5. Photocopy of GST Certificate to be submitted;
6. The Work Order will be given to the successful Tenderer/Firm within 07 (seven) days from the date of opening of the Tender Box;
7. The successful Tenderer/Quotationer/Firm will have to deposit an amount of **Rs.50,000/-** (Rupees Fifty Thousand) only as Security Deposit through Bank Draft or any Bank mode before execution of Supply Order and entering into the Agreement on receipt of the Supply Order;

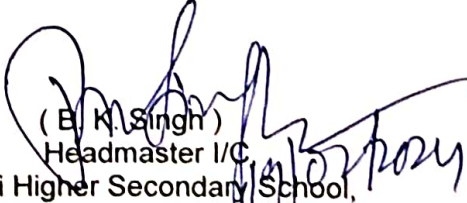

8. If the successful Tenderer fails to supply the materials as per the Order issued by the School Authority within the minimum stipulated time limit. The Tender may be cancelled and Security Money will be forfeited at any stage at the sole option and discretion of the Tender Inviting Authority without assigning any reason.
9. The successful Tenderer will have to supply the materials minimum within 30 (thirty) days.
10. As the work is to be completed urgently, the Tenderer will have to complete the supply in time. The successful Tenderer may be allowed extension of time, period for a reasonable time on special ground solely at the discretion and option of the Tender Inviting Authority (Hindi Higher Secondary School Authority);
11. Payment may be made in full or part or advance after the Supply Order is issued and contract is executed or after completion of full supply and execution of complete work done subject to the satisfaction of Hindi Higher Secondary School Authority. The Hindi Higher Secondary School Authority have the sole option and discretion to make the payment;
12. Part Payment or Advance Payment may be given at the sole option of the Tender Inviting Authority considering the financial status, credential and dependability of the Tenderer / Supplier as well as considering his market report, upto the satisfaction of Tender Inviting Authority;
13. The Tender Inviting Authority (Hindi Higher Secondary School Managing Committee) represented by its Secretary or Headmaster of the School have the sole right to accept or reject any Tender including the highest one and modify & relax the Terms & Conditions to a reasonable extent as per their sole option and discretion;
14. Tender Inviting Authority will have the sole right to accept or reject any Tender including the lowest one without assigning any reason whatsoever, it may be.
